Your background/experience (40 words maximum):

I have been a community organizer for 15 years on campaigns for labor rights, LGBTQ equality, and racial justice. I am on the adult board of iNSIDE oUT 180 and the advisory board of the Durham Solidarity Center.

1. How important is affordable housing to Durham's future and how do you propose ensuring that the city maintains an adequate stock of affordable housing? (50 words maximum)

Providing affordable housing is critical to maintaining the racial and economic diversity of our city. We should partner with nonprofit housing providers to construct housing that is affordable for low-income people and demand that developers who request city funding or zoning changes provide affordable units as part of their developments.

2. What are your ideas to bring more jobs to young people, especially those groups with traditionally higher unemployment rates like young African-Americans? (50 words maximum)

The city should partner with local educational institutions and employers to provide training for living wage jobs that will be coming to the area over the next 10 years (tech, light rail, healthcare, etc.) and target these programs to communities with the highest unemployment rates.

3. What can, or should, Durham do to provide access to efficient, reliable public transportation for all citizens? (50 words maximum)

The city should invest in bus and rail transit options both within Durham and to Chapel Hill/ Raleigh to reduce traffic on our roads and environmental impact. We should target transit improvements in neighborhoods where transit-dependent people live and provide affordable housing in those neighborhoods.

4. Across the nation there is a growing demand to hold police departments more accountable for their actions. Durham's Civilian Police Review Board currently has no authority to investigate or discipline officers. Would you support or oppose giving the board more power to investigate and discipline police officers? (50 words maximum)

It is important that police officers are accountable to the community and that independent oversight of their actions takes place. I would support giving the review board the power to investigate and discipline officers. They should also have the authority to enforce their recommendations and control of the departmental budget.
